IN THE MATTER OF VIEWING, SURVEYING AND LAYING OUT COUNTY ROAD
No. 579

TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY
WE THE UNDERSIGNED Board of County Road Viewers, heretofore instructed to view, survey and locate Road No 579 submit the following report:

Pursuant to an order of the Honorable County Court we met at the office of the County Surveyor at the Court House on the 11th day of December, 1905, We called to our aid

who were by the Surveyor each duly sworn. We viewed, surveyed and located said Road No. 579 as specified in our order. We find said route practicable, the cost of opening said Road would be about Forty Dollars and as there are a traveled Road on the Washington side of the state line parallel with this proposed road 30 feet wide we would most respectfully recommend this Road be established as a public Highway thereby adding to said road sufficient width for all purposes of a public highway 50 feet wide
