has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A strip of land 40 feet wide, being 20 feet on each side of the center line of the survey as shown upon the location map and described as follows, center line described: Beginning at a point 1172 feet north of the southwest corner of section 20, Twp. 5 N, Range 33, E.W.M.: Thence north 82°08' East a distance of 106.8 feet; thence around a 6° curve right a distance of 220.6 feet; thence south 84°40' East a distance of 76.8 feet; thence around a 6° curve left a distance of 421.1 feet; thence north 70°04' East a distance of 678.6 feet; thence around a 5° curve left a distance of 328 feet; thence north 53°40' East a distance of 142.6 feet; thence north 57°31' East a distance of 805.3 feet; thence around a 6° curve left a distance of 260 feet; thence north 41°55' East a distance of 188.5 feet; thence around a 24° curve left a distance of 195.6 feet; thence north 5°02' West a distance of 26.9 feet to the north property line which is the north boundary of the south east quarter of section 20, Twp. 5 N. Range 33, E.W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
