We the undersigned petitioners citizens and
legal voters and house holders of this County
residing in the vicinity where the County road
hereinafter asked to be located and laid out
do respectfully ask and pray:

That a County
road be laid out and located and established in
your County as follows

Commencing at the
S. W. corner of the S. E. quarter of section
2 Two Township 11 four N. R. 33 E. of
the Willamette Meridian In the town of
Helix - Thence North on the line to
within ten rods of the partition fence between the
lands of Messrs Richmond & Henderson - Thence
in a N. Westerly direction to the line - Thence West
on said line about a quarter of a mile Thence
North between Mr. A. J. Richards house and
fence to the S W corner of section 35 T 5
N. R. 33 E near Mr W. A. Olds residence. Thence
West on the line about ten rods. Thence in
a Northwesterly direction, on the east side
of Mr Wilsons well, through his land to the
lane at or near Mr Noah Anspaugh house
as now traveled - Thence N. W. through
Mr Grants land as now traveled - Thence
N. W. through the ^{land} now occupied by Messrs
Schornaker Atkinson Mackelberry and
Edgar in to Vansycle Canyon on the most
practicable route. Thence down said
Vansycle Canyon on the east side as now
traveled, through the land occupied by Mr

Edge in to Vansycle Canyon on the most
 practicable route. Thence down said
 Vansycle Canyon on the east side as now
 traveled, through the land occupied by Mr
 Campbell - Thence through the lands
 now occupied by Messrs Peterson &
 Effinger to intersect the county road
 in said Vansycle Canyon leading from
 the state line to Sher Spring at or near
 the center of section 9 T 5 N R 33 E,
 where said road leaves the said Vansycle
 Canyon - In a word the road to commence
 at the S.W. corner of the S E quarter of section
 2 T 11 N R 33 E. And terminate in
 the center of the road leading from the state line to
 Sher Spring where said road leaves Vansycle
 Canyon and your petitioners will ever
 pray - This petition to be presented at the July
 term of said Court 1883
