Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet on each side of the center line of the Thorn Hollow-Bingham Springs survey as surveyed over and across the South East Quarter of the North West Quarter of Section 4, Twp 2North, Range 35, E.W.M. as hereinafter described. Beginning at a point 380 feet west of the center of said section 4, and known as station 32/34 of the survey; thence proceeding in a north easterly direction along the survey to a point about 145 feet north of the center of said section 4 which is the east boundary of the property, and is known as ststion 36/24.7 of the survey, and contains .45 acres, more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
