In the Matter of the approval of plat of Grand View Orchard Tract, as changed.

Now On this day there is presented to the court the plat of the change in Grand View Orchard Tract, as laid out and platted in Section 24 Tp 6 N R 35 EWM and The court having duly considered the matter and finds that there is no reason why said plat should not be approved, it is,

HEREBY ORDERED, that said plat be and the same is hereby approved.

In the Matter of County Road NO. 768
 petitioned for by Henry M. Somerer, et al, commencing at NW corner SW $\frac{1}{4}$ Sec. 33 Tp. 5 N.R. 29 EWM ROAD NO. 768

Now on This day this matter coming on regularly to be heard upon the report of the Board of County Road Viewers, heretofore instructed at the October 1914 term of this court to view, survey, stake and lay out said proposed road NO. 768, petitioned for an commencing at the NW corner SW $\frac{1}{4}$ of SW $\frac{1}{4}$ Sec. 33 Tp. 5 N.R. 29 EWM thence east two miles to the NE corner SE $\frac{1}{4}$ of SE $\frac{1}{4}$ Sec. 34 said Tp and range and to be 40 feet wide, as a county road, for final hearing, the same having been publicly read on two different days of the same term of court, to-wit: having been publicly read the first time on November 4th, 1914, and publicly read the second time on Nov. 5th, 1914, and plat and field notes being on file and certified to by the surveyor who surveyed the same, and the said Board of County road Viewers, having reported favorably and recommended that said road be established and declared a public highway of Umatilla County, and the Court being satisfied that said road would be of sufficient public utility, it is HEREBY ORDERED, that said report be approved and that the plat and field notes be recorded in the record of Plats and field-notes of Umatilla County, and that the road supervisor through those road district said road runs be and is hereby ordered to open said road for public use.

In the Matter of County Road No. 769, petitioned for by I.M.Allen et al. Road NO. 769

Now on this day this matter coming on regularly to be heard upon the report of the Board of County Road Viewers, heretofore instructed at the October 1914 term of this court to view, survey, stake and lay out said proposed road No. 769 petitioned for as commencing at SW corner Sec. 31 TP 3 N.R. 28 EWM and terminating at the NE corner NW $\frac{1}{4}$ NW $\frac{1}{4}$ Sec. 14 TP 3 N.R. 28, E.W.M., and The said report now being on file and having been publicly read on two different days of the same term of court, to-wit; having been publicly read the first time on Nov. 4th, 1914, and publicly read the second time on Nov. 5th, 1914, and the said Board of County Road Viewers, having reported unfavorably and recommended that said road be not allowed or established, and the court being satisfied that said proposed road would not be of sufficient public utility, it is hereby ordered, that the petition be denied and the road rejected.

It is further ordered that the costs of viewing said road to-wit \$38.00 be paid by the bondsmen Grant Buchanan and H.L.Stanfield

In the Matter of change in County Road No. 747, known as Reservation Road NO. 1

Now on this day there is presented to the court a plat of the change in County Road No. 747, in section 7, 8 & 9 TP. 2 N.R. 33 EWM, showing that said matter was approved by the Department of the Interior, On Sept 25, 1914, said road as changed and to be hereinafter established will be located on the south side of the OWR & N Ry, Right Of way, and parallel thereto, from the North and South center line of Section 7 Tp 2 N.R. 33 EWM eastward to the intersection with the line running north and south between Sections 8 & 9, in said Tp and Range, hence southeasterly to intersect the old road near the center of the West half of Section 9 TP. 2 N.R. 33 EWM and The court having now duly considered the matter, it is,

HEREBY ORDERED, that said change in said road NO. 747, as approved by the Secretary of the Interior, be now accepted by the Court as a county road and the clerk of this court is hereby ordered to place said plat on file and record in the Record of Plats of Umatilla County
