Road No. 908 (Short Mile Road) )

WHEREAS County Road No. 908 (Short Mile Road) is a Public Road approximately 1 mile in length, with a width of 60 feet, located in Sections 10 and 11, Township 2 North, Range 33, E.W.M., and has also been identified as Old County Road No. 747 and Reservation Road No. 1;

WHEREAS the Confederated Tribes of the Umatilla Indian Reservation (CTUIR), requested that the County transfer jurisdiction of Short Mile Road;

WHEREAS on August 15, 2011, an agreement was signed in which the county agreed to initiate action to remove the road from County jurisdiction, and on completion of the removal, tender jurisdiction of the road to the CTUIR;

WHEREAS the Board of Commissioners, pursuant to ORS 368.026, initiated proceedings for withdrawal by requesting the Umatilla County Public Works Department to prepare a report stating the reasons for and effects of the proposed withdrawal;

WHEREAS a public hearing on the proposed withdrawal was set for November 2, 2011;

WHEREAS notice of the public hearing was published in the East Oregonian and mailed to abutting land owners;

WHEREAS the Umatilla County Public Works Department prepared a Report on Withdrawal of County Road Status from County Road No. 908, Short Mile Road, and the report was available for access by interested parties.

NOW THEREFORE, the Board of Commissioners orders that:

1. The Road Official's Report on Withdrawal of County Road Status from County Road No. 908, dated October, 2011, is accepted, and is incorporated into this order by this reference.

2. The reason for withdrawal of the County Road Status is to enable the jurisdiction of the road be transferred to the CTUIR. The road serves CTUIR housing areas and infrastructure. The withdrawal will have minimal impact, and the CTUIR is willing to maintain the road.

3. County Road status is withdrawn from County Road No. 908, also known as Short Mile Road, more particularly described as follows:

A 60-foot wide right-of-way located in Sections 10 and 11, Township 2 North, Range 33, E.W.M., said road being numbered County Road No. 908 and also known as Old County Road No. 747 and Reservation Road No. 1. The centerline of the road is described as follows:

Beginning at a point on the centerline of County Road No. 900 (Mission Road) which bears South  $63^{\circ}02'46''$  West, 309.41 feet from the  $\frac{1}{4}$  corner common to Sections 10 and 11; thence North  $28^{\circ}00'14''$  East, 58.38 feet; thence 181.01 feet along a 167.35-foot radius curve right (the long chord bears North  $59^{\circ}00'32''$  East, 172.32 feet); thence South  $89^{\circ}59'10''$  East, 100.67 feet to said  $\frac{1}{4}$  corner common to Sections 10 and 11; thence North  $89^{\circ}59'10''$  East, 2637.82 feet along the east-west centerline of Section 11 to its center; thence North  $89^{\circ}33'35''$  East, 2110 feet, more or less, along the east-west centerline of Section 11 to the point of curvature of the road as located on March 27, 1937; thence on a 20-degree (286.48-foot radius) curve right a distance of 289.21 feet, more or less, to a point on a line which is parallel to and 134 feet south of the east-west centerline of Section 11 and there terminating. Excepting any portion of the above described road lying within the right-of-way limits of County Road No. 900. Bearings and distances are based on the United States Department of Interior, Bureau of Indian Affairs, plans for Project U. I. R. 7(1) - Short Mile Road.

4. Upon this withdrawal, the improvement, the construction and the repair of County Road No. 908 by Umatilla County shall cease.

5. The withdrawal does not change the status of the road as a Public Road, and the property described in paragraph 3 shall remain a Public Road, over which the public has a right of use.

6. Jurisdiction over Short Mile Road is tendered to the Confederated Tribes of the Umatilla Indian Reservation.
