Known as the OLD OREGON TRAIL Highway

Know all men by these presents, That John Fisher and Martha Fisher, his wife

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to them, the receipt whereof is hereby acknowledged, have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Eighty (80) feet wide, being Forty (40) feet on each side of the center line of said road, as surveyed over and across the South-east Quarter of the Southwest Quarter of Section 5, Township 1 North, Range 34 East, W.M. Said center line being more particularly described as follows:

Beginning at a point on the east boundary of said property which point is approximately 622 feet north of the south quarter corner of section 5, T. 1 N., R. 34 E. W. M.; thence north 57° 55' west a distance of 120.4 feet; thence on a four degree curve to the right a distance of 482.3 feet; thence north 36° 49' west a distance of 266.7 feet; thence on a four degree curve to the left a distance of 140.7 feet more or less to a point on the north boundary which point is approximately 715 feet west and 1310 feet south of the center of said Section 5. Said tract after deducting that portion included in the present existing State Highway contains 1.71 acres more or less.
