Known as the OLD OREGON TRAIL Highway

Know all men by these presents, That Bureau of Catholic Indian Missions and St. Andrews School,

of the County of Umatilla

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to them, the receipt whereof is hereby acknowledged,

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Eighty (80) feet wide, being Forty (40) feet on each side of the center line of said road, as surveyed over and across

the Southwest Quarter of the Southeast Quarter of Section 24, Township 2 North, Range 33 East, W.M. and the Northwest Quarter of the Northeast Quarter of Section 25, same Township and Range and more particularly described as follows;

Beginning at a point on the west boundary of said property, which point is approximately 1305 feet north of the south quarter corner of said Section 24, T. 2 N., R. 33 E. W. M.; thence on a 1 degree curve right, the long chord of which bears south 15 degrees 27' east a distance of 55 feet; thence S 15 degrees 10' E a distance of 1720 feet; thence on a 4 degree curve right a distance of 120.8 feet; thence S 10 degrees 19' E a distance of 830 feet more or less to a point on the east boundary of said property, which point is approximately 1320 feet north and 650 feet east of the center of said Section 25.

Said tract after deducting that part included in the present existing State Highway contains 1.53 acres more or less.
