

ROAD NOTICE.

To All Persons Whom it May Concern :

Notice is hereby given that a petition will be presented to the County Court of the State of Oregon, for Umatilla County, by the undersigned, who are residents and householders of said County and State and reside in the vicinity of the hereinafter described route for a County road, at the *April* term of said County Court, to-wit. on the *First* day of *April* 1889, praying said court to lay out, locate and establish a county road in said County and State, commencing, running, and terminating as follows, to-wit :

Commencing *At the South East corner of section 15. Thence running due north two miles to the north East corner of section 10 on section line between ^{said} sections 13 & 14 and 10 & 11 in Township 4 North Range 33 East of Willamette Meridian in Umatilla County State of Oregon and said road terminates at County road at the north East corner of section 10 T⁴ R³³ E. in said County and State.*

Said road to be *Forty* feet wide.
