

## PUBLIC NOTICE

Notice is hereby given that the Umatilla County Board of Commissioners has initiated proceedings for the vacation of several undeveloped road rights of way located in Sections 20 and 29, Township 3 North, Range 33 East of the Willamette Meridian. The roads are more particularly described as follows and are shown shaded in gray on the attached drawing.

### Roads to be Vacated:

1. Old County Road No. 778 in its entirety, as established by Court Order on April 6, 1916, excepting therefrom any portion lying within the right of way limits of County Road No. 975, Myrick Road, and County Road No. 973, Adams Road. Old County Road No. 778 is located in Sections 20 and 29, Township 3 North, range 33 East of the Willamette Meridian.
2. That portion of Old County Road No. 245 as established by Court Order on January 21, 1885 (also known as Old County Road No. 115, established by Court Order on January 24, 1882) located in the Southeast  $\frac{1}{4}$  of the Southwest  $\frac{1}{4}$  and the Southwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of Section 20, Township 3 North, Range 33 East of the Willamette Meridian lying south of a line 720 feet north of and parallel to the south line of Section 20, excepting therefrom that portion lying within the right of way limits of County Road No. 975, Myrick Road.
3. That portion of Old County Road No. 245 as established by Court Order on January 21, 1885 (also known as Old County Road No. 115, established by Court Order on January 24, 1882) located in the North  $\frac{1}{2}$  of Section 29, Township 3 North, Range 33 East of the Willamette Meridian lying north of a line 1337 feet south of and parallel to the north line of Section 29, excepting therefrom that portion lying within the right of way limits of County Road No. 975, Myrick Road.
4. That portion of Old County Road No. 245 as established by Court Order on January 21, 1885 (also known as Old County Road No. 115, established by Court Order on January 24, 1882) located in the Southeast  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  and the Southwest  $\frac{1}{4}$  of the Northeast  $\frac{1}{4}$  of Section 29, Township 3 North, Range 33 East of the Willamette Meridian lying south of a line 291 feet north of and parallel to the east-west centerline of Section 29, excepting therefrom that portion lying within the right of way limits of County Road No. 975, Myrick Road.

5. That portion of Old County road No. 245 as established by Court Order on January 21, 1885 (also known as Old County Road No. 115, established by Court Order on January 24, 1882) located in the South ½ of Section 29, Township 3 North, Range 33 East of the Willamette Meridian lying south of the east-west centerline of Section 29 and north of the right of way limits of County Road No. 973, Adams Road, excepting therefrom that portion lying within the right of way limits of County Road No. 975, Myrick Road.
6. Any and all right or title to County Road No. 961, Elgin Road, located in the Northwest ¼ of Section 29, Township 3 North, Range 33 East of the Willamette Meridian, for which Umatilla County has no recorded legal right of way.

The Umatilla County Board of Commissioners, under authority of ORS 368.326 to 368.366, intends to hold a public hearing on the vacation of said roads on May 23, 2011, at 9:00 a.m. in Room 114, Umatilla County Courthouse, Pendleton, Oregon. Any persons wishing to be heard on this subject may attend this hearing in person or submit to the Department of Public Works in writing or by e-mail any appropriate information for consideration by the Board of Commissioners, who subsequently will determine whether the roads shall be vacated.
