Court met pursuant to adjournment and there were present:

And after due proclamation of the opening of court by the proper officer, the following business was transacted together with claims allowed as shown by Abstract of Claims Book No. 3.

In the matter of County Road commencing at a point on County Road on the West line of Section 31, T₃ N. R. 33 E. W. M. about 60 rods South of the N.W. corner of said section running southeasterly down draw and canyon through said section to a point on the County road running up and down Wild Horse Creek in Umatilla County, Oregon, said point of intersection with Wild Horse Road to be most convenient point, that can be reached readily,

Now on this day comes the Report of the viewers W. D. Hansford, J. S. McLeod and Dot Livermore, heretofore appointed at the March, 1899, term of this court to view out and report upon the location of the above road as a County Road for final hearing, the same having been read upon a previous day of this court, to-wit: The March, 1899, term said road being described as follows: Commencing at a point on County road on the West line of Section 31, T₃ N. R. 33 E. W. M. about 60 rods South of the N.W. corner of said section, running southeasterly down draw and canyon through said section to a point on the County road running up and down Wild Horse Creek in Umatilla County, Oregon, said point of intersection with Wild Horse Road to be most convenient point that can be reached readily. Said road to be sixty feet wide, and the said viewers having reported favorably and recommended the establishing of the same as a County Road, and the field notes and plat of survey being duly on file and certified to by the Surveyor appointed to survey the same and there being no remonstrance or claim for damages on file against said road.

It is therefore ordered by the court that the report of said viewers

be accepted and that said road be established as a County Road in accordance with the report of said viewers, and that the said report, field notes and plat of survey thereof be recorded as by law required, and that the Superintendent of County Roads be directed to open the same for public use as a County Road.
