WHEREAS in accordance with ORS 368.206, the Umatilla County Board of Commissioners issued Order No. RD2015-03 to survey and to monument a portion of Lee Street Grade (a.k.a. Northeast 8<sup>th</sup> Street), County Road No. 983, located in the Southwest ¼ of Section 2, Township 2 North, Range 32 E.W.M. and lying between Southeast Byers Avenue and the unimproved roadway dedicated to the Public and accepted by the City of Pendleton and Umatilla County, Reel 78, Pages 1355 through 1363, Umatilla County Deed Records, and

WHEREAS the Department of Public Works has found that the road as traveled and used for ten (10) years or more does not match the existing road records and has recommended that the Board of Commissioners legalize the road as shown on the survey completed by William R. Wells, and

WHEREAS persons interested or concerned about this proposed legalization may examine said survey and other documents concerning this proposed action by contacting the Umatilla County Department of Public Works, 3920 Westgate, Pendleton, Oregon 97801, phone (541)278-5424, Monday through Friday, 8:00 a.m. to 5:00 p.m.

NOW THEREFORE IT IS ORDERED as follows:

1. A hearing is set for November 4, 2015, at 9:15 a.m. in Room 130 of the Umatilla County Courthouse, 216 S.E. Fourth Street, Pendleton, Oregon, to hear public testimony both for and against the proposed legalization and determine if the above described road shall be legalized in its present location as traveled and used for ten (10) years or more.
2. In accordance with ORS 368.206(1) (c), 368.406, 368.411, and 368.416, those persons whose property abuts said road legalization shall be notified of this hearing by certified mail at least 30 days before the date of the hearing, notice of the hearing shall be posted in no less than three (3) public places no later than 20 days before the hearing, and notice of the hearing shall be published in the East Oregonian once at least 20 days before the hearing and once within 10 days of the hearing.
