WHEREUPON, a term of said Court is begun and held on Monday the 7th day of May 1906, the same being the 5th Judicial day of said term and among other proceedings the following was had to-wit:

Now on this day comes the report of the Board of County Road Viewers, heretofore instructed at the March term of 1906, of this Court to view, lay out and report upon said proposed County road No.584, deeded by Fred Rohde, and Dorä Rohde, John H. Hagen and Ida Hagen, C.H. Rosenberg and Annie Rosenberg, Thomas R. Hampton and Nina L. Hampton, Cornelius Daniels, E. J. Sommerville and Clementine Sommerville, Commencing at the Northeast corner of the Northwest Quarter of Section 5 Tp.3 N. Range 32 E.W.M.; run thence West 20 feet, thence South 3 miles to a point 20 feet West of the Southeast corner of SW 1/4 Section 17 said Tp. and Range thence East 40 feet to a point 20 feet East of the Southeast corner of SW 1/4 said Section 17, thence North 3 miles to a point 20 feet East of Northeast corner of the Northwest Quarter Sec. 5, said Tp. and Range, thence West 20 feet to the place of beginning. , as a County road , coming on for final hearing, the same having been publicly read on two different days of the same term of Court, being publicly read the first time on the 4th day of May 1906, and publicly read the second time on the 7th day of May 1906, and the said Board of County Road Viewers having reported favorably and recommended the opening of said road as a County road, and the field notes and plat of survey, being on file and certified to by the surveyor appointed to survey the same, and the Court being satisfied that the said grantors herein are the owners of all of the deeded land over which it is desired to establish said County road, and

the Court being satisfied that said road would be of sufficient public utility, it is, THEREFORE HEREBY ORDERED, that said road be accepted as a County road, and that the report of the Board of County road viewers, be accepted and that said report, survey/profile and plat be recorded in the record of plats and field Notes of Umatilla County, and the Road Supervisor, through whose district said road runs, be and he is hereby ordered, to open the same for public travel.
