has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide being thirty feet on each side of the center line of the Despain-Gulch Market Road as surveyed over and across the Northeast Quarter of Section 10, Township 3 North, Range 31 East, W.M. and as more particularly described as follows:

Beginning at a point on the section line 1360.0 feet North of the Quarter section corner common to sections 10 and 11, Township 3 North, Range 31 East, W.M. which point is known and designated as station 281/67.1 P.O.T. thence North 68°46' West 771.0 feet, thence on a 5730.0 foot radius curve right 523.3 feet, thence North 63°32' West 1602.8 feet to a point known and designated as station 310/64.3 which point is 43 feet South of the Quarter Section corner common to Sections 3 and 10, Township 3 North, Range 31 East W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
