paid to him the receipt whereof is hereby acknowledged

has granted, bargained, sold and conveyed, and by these presents do to grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land 60 feet wide being 30 feet on each side the center line of the Despain Gulch Market road survey as surveyed over and across said property and as more particularly described as follows;

Beginning at a point 658.0 feet North of the Quarter section corner common to sections 12 and 13 T. 3 N., R. 31 E. W.M., thence N. 75° 48' W. a distance of 1544.4 feet, thence on a 2864.9 foot radius curve right a distance of 812.5 feet, thence N. 59° 33' W. a distance of 3223.0 feet to a point 603.0 feet East of the center of Section 11 T. 3 N., R. 31 E. W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

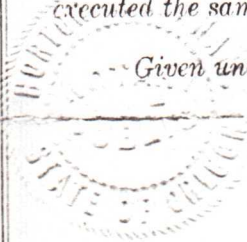
