has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: a strip of land sixty feet wide being thirty feet on each side of the center line of the Despain Gulch Market Road as surveyed over and across the Northwest Quarter of Section 29, Township 4 North, Range 31 East W.M. and as more particularly described as follows;

Beginning at a point on the section line 310.0 feet East of the Quarter Section corner common to Sections 29 and 30, Township 4 North, Range 31 East, W.M. which point is known and designated as station 507/26.7, thence North 56° 55' West 00 feet thence on a 1432.5 foot radius curve left 243.2 feet, thence North 66° 39' West 95.0 feet to a point known and designated as station 510/64.9, which point is 150.0 feet North of the Quarter Section corner common to Sections 29 and 30, Township 4 North, Range 31 East W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
