in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to me the receipt whereof is hereby acknowledged

have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: a strip of land sixty feet wide being thirty feet on each side of the center line of the Despain Gulch Market Road as surveyed over and across the Northeast Quarter of Section 32 Township 4 North Range 31 East, W.M. and as more particularly described as follows;

Beginning at a point on the section line 1351.0 feet North of the Quarter Section corner common to Sections 32 and 33, Township 4 North, Range 31 East, W.M. Which point is known and designated as station 442/22.0, thence North 58°10' West 24.9 feet, thence on a 286.5 foot radius curve right 240.2 feet, thence North 10°08' West 285.0 feet, thence on a 573.0 foot radius curve left 537.5 feet, thence North 63°53' West 455.5 feet, thence on a 2865.0 foot radius curve right 390.8 feet, thence 56°04' West 324.1 feet to station 464/80.0, which point is 1182.0 feet East of the Quarter Section corner common to sections 29 and 32, Township 4 North Range 31 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
