In the Matter of Locating, Establishing, Altering, Widening, Straightening and Changing a County Road From the Umatilla River and Mission Station on the O.W.R. & N. Railroad southerly on the Umatilla Indian Reservation, all in Umatilla County, Oregon.

RESOLUTION

County Road No. 893

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed from the Umatilla River southerly across a portion of the Umatilla Indian Reservation.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of July 1929, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed County Road No. 893

shall commence, run and terminate as follows, to-wit: Beginning at a point known and designated as station 1475.8, which point is 135 feet south and 432 feet east of the section corner common to sections 3, 4, 9 and 10, Township 2 North, Range 33 East, W.M. running thence southerly following the Mission South Market Road Survey to a point known and designated as station 415/06.6 which point is coincident with the section corner common to sections 8, 9, 16 and 17, Township 1 North, Range 33 East, W.M.

The right of way or roadway to be a strip of land 60 feet wide, being 30 feet on each side of the above described line.

Be IT FURTHER RESOLVED that a public necessity for the road or highway is hereby declared to exist for the following reasons, to-wit: that it will furnish an outlet for a large amount of wheat land.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular Sept. term for the year 1929, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon, on the 4th day of Sept. 1929 at 10 o'clock, A.M.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk, be posted by Walter M. Ransom as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
