now on this day comes the report of the viewers, Thomas McDouwen, W. J. Sellers and J. W. Sturdivant, heretofore appointed at the July term, 1895, of this Court, to view out and report upon the location of the above described road as a County road for final hearing, the same having been read upon a previous day of this Court, to-wit: the Sept. term, 1895, and the said viewers having reported favorably and recommended the establishing of the same as a County road in and for Umatilla County, Oregon, and the field notes and plat of survey being duly on file and certified to by the surveyor appointed to survey the same, and there being no remonstrance or claim for damages on file against said road, ~~the protest against the vacating of certain part of road, as set forth in Petition and notices, of T. M. Salterburg being denied.~~

It is therefore ordered by the Court that said road be established as a County road in accordance with the report of said viewers, field notes and plat of survey thereof be recorded as by law required and that the Supervisor through whose district said road runs be directed to open the same for public use as a County Road.
