To The Board of Commissioners of Umatilla County, Oregon

Whereas the paved roadway constructed on the platted right-of-ways of Meadow Drive and Bridle Drive within the Green Meadows Subdivision were accepted as part of the Umatilla County road system on April 5th, 1961 by the then County Court (see letter dated April 5, 1961, copy attached):
