WHEREAS, in accordance with ORS 373.270(1)(a), the Umatilla County Board of Commissioners has determined it to be in the best interest of the County to transfer jurisdiction of a portion of County Road No. 1100, Stage Gulch Road (also known as NW A Avenue), from approximately the South line of Section 31, Township 3 North, Range 32, northerly to Northeast corner, Section 36, Township 3 North, Range 31, all located within or proposed to be annexed within the corporate limits of the City of Pendleton, Oregon, to the City of Pendleton, and

WHEREAS, the City of Pendleton and Umatilla County executed a Memorandum of Understanding on April 11, 2000, whereby the City would accept jurisdiction over a portion of Avenue "A" Avenue/Stage Gulch Road from NW 56th Drive to northeast corner of the Pinkerton property (Section 36) at such time as any portion of the referenced Pinkerton property was annexed or developed, and

WHEREAS, conditions for the transfer of the road to the City of Pendleton have been met by the proposed annexation of the Pinkerton property.

NOW THEREFORE, the Board of Commissioners orders that:

1. A hearing is set for May 27, 2009, at 9:15 a.m. in Room 114 of the Umatilla County Courthouse, 216 S.E. Fourth Street, Pendleton, Oregon, to hear public testimony both for and against the proposed jurisdiction transfer and determine if the above described road shall be transferred to the City of Pendleton, Oregon.
2. In accordance with ORS 373.270(2)(a) notice of the hearing shall be posted in 3 public places, one of which shall be within the city limits of Pendleton, Oregon. Persons interested in or concerned about this proposed jurisdiction transfer may obtain





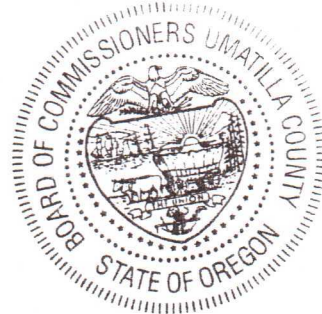
