

Road Petition.

To the Honorable the County Court of the State of Oregon for Umatilla County:

We the undersigned residents and house holders of Umatilla County, and living in the vicinity of the heretofore proposed road, hereby petition this Court for the viewing locating and establishing of a county road, described as follows, namely: Commencing at the center, or quarter post on the east boundary line of Section fifteen (15) in Township Three (3) North, of Range Thirty one (31) East of the Willamette meridian, the same being a point on County Road Number 182, being the road running from the school house in Sec 10, T3 N R 31 E. to intersection of County road running from Reedilton to Umatilla via Prospect - and running from said point due west through the center of ^{said} section fifteen (15) Township Three (3) North, of Range Thirty one (31) East, one mile, to the center of the east boundary line of Section sixteen (16) same Township and Range, thence north on said line between said sections fifteen (15) and sixteen (16) eighty (80) rods, thence west across said section six

teen (16) and distant 80 rods from its northern boundary, - one mile, to the line between sections sixteen (16) and seventeen (17); thence south eighty (80) rods on said line between said sections sixteen ⁽¹⁶⁾ and seventeen (17) to the center ^{of}, or quarter post on said line; thence due west through the center of sections seventeen ⁽¹⁷⁾ and eighteen (18), Township Three ⁽³⁾ North, of Range Thirty one (31) East; and the center of section thirteen (13) Township Three (3) North, of Range Thirty (30) East, three miles, to the quarter post on the section line between said sections thirteen ⁽¹³⁾ and section fourteen (14) same Township and Range; thence south on the section line in said Township and Range between said sections thirteen ⁽¹³⁾ and fourteen (14) one-half mile, between sections twenty three (23) and twenty four (24) same Township and range one mile; between sections twenty five (25) and twenty six (26) same Township and Range, one mile, between sections thirty five ⁽³⁵⁾ and thirty six (36) same Township and Range,

three quarters of a mile; to a point on said section line between sections thirty five (35) and thirty six (36) eight (8) rods north of the southwest corner of said section thirty six (36). Thence southwest ^{or} diagonally across said section thirty five (35) and ^{across} section two (2) in Township two (2) north of Range thirty (30) East, by the most practicable route to what is known as Baker's bridge on the Unatilla river.
