TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed Beginning at the SW corner of Sec. 26, Twp 4, N.R. 29, East W. M. running thence North one half mile on the North and South Section line between Sections 26 and 27, Twp. 4, N.R. 29, E.W.M.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of September 1940, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed.....

shall commence, run and terminate as follows, to-wit: Beginning at the SW corner of Sec. 26, Twp. 4, N.R. 29, E.W.M. running thence North one half mile on the North and South Section line between Sections 26 and 27, Twp. 4, N.R. 29, E.W.M.

The right of way or roadway to be a strip of land 40 feet wide, being 20 feet on each side of centerline of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: To provide an outlet to the County graveled road for farmers residing south of Stage Gulch in that vicinity and for the convenience of the general public.

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular October 21st term for the year 1940 at 10 A.M. of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk be posted by Willard Brown, as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road. And that this Resolution be duly entered in the Commissioners Journal.
