has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Fifteen (15) feet on Forty Five feet on the North West South East side and _____ side of the center line of said road, as surveyed over and across South one half (S 1/2) of the North one half (N-1/2) of the North West one quarter (NW 1/4) of the _____ South East one quarter (S E -1/4)

of Section 33 Township 4N, Range 29 East W. M.

Beginning at Station 0 / 44 of the Stanfield - Despain Gulch Highway Survey which Station is approximately 20 feet East and 817 feet North of the N.E. Corner of the SE-1/4 of the SW-1/4 which is common to Sections 33 Township 4N Range 29 East W. M.

Thence running in a North easterly direction approximately 413 feet to Station 4 / 57 of the said survey, which Station is approximately 1070 feet North and 329 feet East of the NE corner of the SE-1/4 of the SW-1/4 of which is common to Sections 33 Township 4N

Range 29 E East W. M. Containing 0.57 acres more or less. Same to revert to grantor whenever same ceases to be used for road purposes.
