WHEREAS, in accordance with ORS 373.270(6) the City of Hermiston, Umatilla County, Oregon, has initiated action to acquire jurisdiction of that portion of County Road No. 1197, Southeast 9th Street, lying between the northerly right-of-way line of Port Drive, a platted road in the Village Port Subdivision, and the southerly right-of-way line of East Highland Avenue, from Umatilla County, and

WHEREAS, pursuant to ORS 373.270(4) a public hearing was held on November 25, 1998, and a continuation of same public hearing was held on December 16, 1998, to hear public testimony both for and against the proposed transfer, and determining it to be in the public interest to transfer the above described portion of Southeast 9th Street to the City of Hermiston:

IT IS HEREBY ORDERED that in accordance with ORS 373.270(6)(b) jurisdiction over the above described portion of County road No. 1197 (Southeast 9th Street) be transferred to the City of Hermiston, Oregon, and that the full and absolute jurisdiction over the road for all purposes of repair, construction, improvement, and the levying and collection of assessments shall vest in the City.

RESOLUTION NO. 1527




