ORDER NO. RD97-04

WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.073, initiate proceedings to acquire title in real property for public road purposes on its own action, and

WHEREAS, the proceedings were initiated with a Memorandum of Understanding between the Board of Commissioners and property owners dated September 4th, 1991, and a survey order to the Umatilla County Department of Public Works dated May 5th, 1995, and

WHEREAS, pursuant to ORS 368.106 the survey has been completed and all necessary property has been deeded to the County:

THEREFORE IT IS NOW ORDERED that the road shown on County Survey #96-202-C filed in the Umatilla County Surveyor's Office and described below be accepted into the County Road System and become part of County Road No. 1198, East Highland Extension.

LEGAL DESCRIPTION: A strip of land for road purposes located in the south halves of Sections 9 and 10 and in the north halves of Sections 15 and 16, Township 4 North, Range 29 E.W.M., being 60 feet in width and lying 30 feet on each side of the following described centerline:

Commencing at a brass-capped monument marking the corner common to Sections 9, 10, 15, and 16, Township 4 North, Range 29 E.W.M.; thence North 89 Degrees 50 Minutes 37 Seconds East, 5297.11 feet to the true point of beginning of this description; thence South 89 Degrees 10 Minutes 31 Seconds West, 11.74 feet; thence South 89 Degrees 32 Minutes 57 Seconds West, 782.38 feet; thence South 89 Degrees 42 Minutes 25 Seconds West, 715.06 feet; thence South 89 Degrees 33 Minutes 28 Seconds West, 714.07 feet; thence South 89 Degrees 35 Minutes 50 Seconds West, 848.50 feet; thence South 89 Degrees 38 Minutes 23 Seconds West, 873.72 feet; thence South 89 Degrees 39 Minutes 02 Seconds West, 627.25 feet; thence South 89 Degrees 41 Minutes 52 Seconds West, 668.09 feet; thence South 88 Degrees 29 Minutes 27 Seconds West, 679.62 feet; thence South 88 Degrees 46 Minutes 50 Seconds West, 638.52 feet; thence South 88 Degrees 40 Minutes 48 Seconds West,

666.56 feet; thence South 88 Degrees 57 Minutes 46 Seconds West, 651.03 feet; thence South 88 Degrees 31 Minutes 33 Seconds West, 568.72 feet; thence South 89 Degrees 59 Minutes 35 Seconds West, 995.25 feet; thence South 89 Degrees 54 Minutes 08 Seconds West, 1003.28 feet to a punch-marked railroad spike set in the intersection of South Edwards Road and East Highland Extension that bears South 17 Degrees 44 Minutes 41 Seconds East, 14.70 feet from the Northwest Corner of Section 16, T. 4 N., R. 29 E.W.M. and there terminating.
