RESOLUTION

WHEREAS the Umatilla County Board of Commissioners may under ORS 368.585, when it deems it necessary, order a county road, that has been used and traveled by the public, to be surveyed, platted and recorded as provided in ORS 368.590 to 368.610, and

WHEREAS it appears to the Umatilla County Board of Commissioners that doubt exists as to the legal establishment of the Dunn - McClanahan Road, and

WHEREAS the county is prohibited by law under ORS 386.551 to expend county road funds on roads other than legal county roads, and

WHEREAS the Umatilla County Road Department did in 1968 cause a road to be built, more precisely described as follows:

Beginning at a point N89°40'40"E 1328.68 feet of the corner common to Section 19, 20, 29 and 30, Township 5 North, Range 28, East, W.M., which is the West right-of-way line of County Road #754 (Power Line Road); thence S89°40'40"W 1328.68 feet to the corner common to Sections 19, 20, 29 and 30, Township 5 North, Range 28 East, W.M.; thence N89°56'25"W 5,302.68 feet along the section line between Sections 19 and 30, Township 5 North, Range 28 East, W.M. to the corner common to Sections 24, 25, 19 and 30, Township 5 North, Range 27 East, W.M.; thence S89°52'50"W 5,263.75 feet along the section line between Sections 24 and 25, Township 5 North, Range 27 East, W.M. to the corner common to Sections 23, 24, 25 and 26, Township 5 North, Range 27 East, W.M. which is the ending point, said road has a sixty (60) foot right-of-way lying thirty (30) feet on either side of the above described centerline.

IT IS THEREFORE RESOLVED THAT IT IS THE INTENTION OF THE UMATILLA COUNTY BOARD OF COMMISSIONERS as provided in ORS 368.585 to legalize the Dunn - McClanahan Road, and

THEREFORE the Umatilla County Board of Commissioners ORDERS the Umatilla County Roadmaster to survey, plat and record the Dunn - McClanahan Road as provided under ORS 368.530, and

BE IT FURTHER RESOLVED that true copies of this resolution, properly certified to be such by the Umatilla County Clerk, shall be posted by the Umatilla County Roadmaster or his assistants in four (4) places in the vicinity of said road; that one (1) copy be posted upon the bulletin board in the West corridor of the Umatilla County Courthouse in Pendleton, Oregon, said County Courthouse being the place where the Umatilla County Board of Commissioners' meetings are held; that copies shall be mailed to the record owners of the land on which the road is now established; and that this resolution be duly entered in the Commissioners' Journal; and that a hearing be held before the Umatilla County Board of Commissioners in Room 114, of the Umatilla County Courthouse, Pendleton, Oregon, on Tuesday, the 27th day of August, 1974, at 10:00 o'clock, at which time objections and remonstrances will be heard.
