Beginning at a point 17 feet North of the SE Corner of the SW Quarter of the SE Quarter of Section 4, Township 4 North, Range 28 E.W.M., thence North 16 feet, thence West 208 feet, thence South 16 feet, thence East 208 feet to the point of beginning of the portion to be vacated.

WHEREAS, By order of the County Commissioners, the County Roadmaster was directed to examine the above described portion of the road to be vacated and make a report on the road

WHEREAS, a public hearing on the above described portion of road to be vacated was set for October 1, 1980, at 10:00 a.m., in Room 114 of the Umatilla County Courthouse,

WHEREAS, notice of the hearing was given at least 30 days before the hearing pursuant to ORS 368.575,

WHEREAS, proof that notice was given was made by affidavit of the County Roadmaster and filed with the County Clerk,

WHEREAS, on October 1, 1980, a public hearing was held on the report of the County Roadmaster,

WHEREAS, the Board of County Commissioners finds that the above described portion of County Road #611 is burdensome to maintain, and is not needed as a part of the County Road System, and further, that the public will be benefited by the vacation,

NOW, THEREFORE, IT IS ORDERED that the above described portion of County Road #611 be vacated.

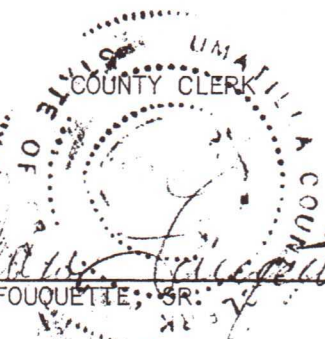
