Beginning at the center of the South line of Section 25, Township 5 North, Range 28, E.W.M., and continueing South on the center line of Section 36, to the center of Section 36, Township 5 North, Range 28, E.W.M., in Umatilla County, Oregon.

and the examination and report having been made and said report being before the court, and the same declared in substance that said road should be vacated and that it is not advisable to preserve the same for any future public road and is useless and burdensome to maintain and that the public will be benefitted by its vacation and it appearing now that it would be the duty of the court to set a time and place for hearing on said report of the County Roadmaster and to cause notice of said hearing to be given by advertisement posted at the place of holding the County Court namely; at the County Court House in Pendleton, Oregon, and at three public places in the vicinity of the said road so sought to be vacated for at least thirty days before the date of hearing on the report of the County Roadmaster aforesaid.

IT IS THEREFORE ORDERED that hearing should be had on said report of the County Roadmaster at the County Court at the County Court House at Pendleton, Oregon, at 10:00 o'clock in the forenoon on the 22nd day of December, 1930, and

IT IS FURTHER ORDERED that the County Clerk of Umatilla County Oregon, prepare and W. E. O. Criger, is hereby ordered to

post notices of said hearing at the place of holding this court, to-wit: one on the bulletinboard at the West Door of the County Court house at Pendleton, Oregon, and also in three public places in the vicinity of said road or portion of County Road sought to be vacated for at least thirty days prior to said 22nd day of December, 1930, and that due proof of said advertisement shall be made to this court as by statute provided.
