RESOLUTION

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed.....

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of March 17th, 1948, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed road

shall commence, run and terminate as follows, to-wit:

Beginning on the East City Limits of the City of Umatilla on the intersection of third street, running thence N. 73° 13' E. a distance of 625.2 feet, said portion of the above described road shall be 60 feet in width. Thence continuing N. 73° 13' E. a distance of 870 feet more or less to a point, this portion of the road shall be 70 feet in width. Thence continuing N. 73° 13' E a distance of 2640 feet. This portion of the road shall be 80 feet in width. Thence continuing N. 73° 13' E. a distance of 1004.6 feet more or less to a point on the west line of Tax No. 2 of Section 9, Tp. 5 N.R. 28 E.W.M. This portion of the road last above described shall be 60 feet in width.

The right of way or roadway to be a strip of land 60 feet to 80 feet ~~feet wide, being varying in width from~~

of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: With the construction of McNary Dam, the road is greatly needed at this time

BE IT FURTHER RESOLVED that the above entitled matter be heard at the regular 10 O'Clock A.M. April 26th term for the year 1948, of said County Court at the County Court House at Pendleton, in the County of Umatilla, State of Oregon.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk be posted by County Roadmaster as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road. And that this Resolution be duly entered in the Commissioners Journal.
