ORDER NO. RD2001-19

**IN THE MATTER OF LEGALIZATION)
OF MUNGER LANE,)
COUNTY ROAD #1287)**

WHEREAS, the Umatilla County Board of Commissioners may, under authority of ORS 368.201 to 368.221, order a county road that has been used and traveled by the public for ten (10) years or more to be surveyed and recorded, and

WHEREAS, the Umatilla County Board of Commissioners ordered the survey of Munger Lane (County Road #1287) lying east of and adjacent to the City Limits of Umatilla in Section 9, Township 5 North, Range 28 E.W.M., and

WHEREAS, the Notice of Hearing was posted and all owners of abutting property affected by the legalization procedure were served copies of the Notice of Hearing, and

WHEREAS, the Umatilla County Board of Commissioners on August 15, 2001, held a public hearing and finding that it would be in the public interest to legalize the road:

THEREFORE IT IS NOW ORDERED that the road be legalized as follows:

A 70-foot wide right-of-way lying 30 feet east of and 40 feet west of the following described centerline:

Commencing at a brass-capped monument marking the Southwest Corner of Section 9, Township 5 North, Range 28 E.W.M.; thence N84°57'08"E, 1319.98 feet to a railroad spike on the easterly right-of-way line of Interstate 82 and the true point of beginning of this description; thence N00°55'34"E, 280.86 feet to a railroad spike in the center of County Road No. 1276 (Third Street) and the terminus of this description.

Excepting therefrom that portion lying within the rights-of-way of Interstate 82 and County Road No. 1276. Together with that area lying between the above described road and the easterly right-of-way line of Interstate 82 if the above described road were extended south.

THE PLAT OF THE ABOVE DESCRIBED ROAD IS RECORDED AS UMATILLA COUNTY SURVEY NO. 01-86-C.
