In the Matter of Accepting the Public Roads Known as West Angus Avenue, West Olive Avenue, and Southwest 10th Street into the County Road System

Order No. RD 91-19

Whereas, in accordance with ORS 371.610 a county governing body may designate any public road improved under ORS 371.605 to 371.660 as a county road without invalidating the assessments levied for the purpose of the improvements, and

Whereas, at a public hearing on June 25, 1996, the Umatilla County Board of Commissioners agreed to accept the public roads known as West Angus Avenue, West Olive Avenue, and Southwest 10th Street into the county road system after they were improved to Umatilla County standards, and

Whereas, said improvements were completed on October 12, 1996 and accepted by the Umatilla County Director of Public works on February 18, 1997, and

Whereas, the survey for the Angus Acres subdivision, recorded in Plat Book #9, Page 25 in the Umatilla County Records Office, and the monuments set in said subdivision, satisfies the requirements of ORS 368.106 for surveys and monumentation:

Now Therefore, it is Hereby Ordered that the following described roads be accepted into the county road system and that their numbers be established as described below:

- 1. West Angus Avenue - That portion of West Angus Avenue lying east of the easterly right-of-way line of State Highway 207 and west of the westerly right-of-way line of Southwest 9th Street. Said Road is 50 feet in width and approximately 1260.66 feet in length and lies entirely within the Angus Acres Subdivision (Plat Book 9, Page 25) in the Northwest 1/4 of the Southwest 1/4 of Section 15, Township 4 North, Range 28 E.W.M. and is assigned County Road Number 1358.
2. West Olive Avenue - That portion of West Olive Avenue lying east of the easterly right-of-way line of Southwest 10th Street and west of the westerly right-of-way line of Southwest 9th Street. Said road is 50 feet in width and approximately 608.81 feet in length and lies entirely within the Angus Acres Subdivision (Plat Book 9, Page 25) in the Northwest 1/4 of the Southwest 1/4 of Section 15, Township 4 North, Range 28 E.W.M. and is assigned County Road Number 1298.
3. Southwest 10th Street - That portion of Southwest 10th Street lying North of the northerly right-of-way line of County Road No. 1196 (Gettman Road) and south of the point where right-of-way width changes from 50 feet to 25 feet west of Lot 1 Block 5. Said road is 50 feet in width and approximately 947.23 feet in length and

lies entirely within the Angus Acres Subdivision (Plat Book 9, Page 25) in the Northwest ¼ of the Southwest ¼ of Section 15, Township 4 North, Range 28 E.W.M. and is assigned **County Road Number 1297**.
