BARGAIN AND SALE DEED

KNOW ALL MEN BY THESE PRESENTS, That Ned E. Davis and Valetta L. Davis, husband and wife, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Umatilla County hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Umatilla, State of Oregon, described as follows, to-wit:

Commencing at the center of Section 16, in Township 2 North, Range 32; thence North 89° 55' 30" West along the South line of the Southeast Quarter, of the Northwest Quarter, a distance of 944.31 feet; thence North 10° 34' 00" West, a distance of 560 feet; thence North 89° 55' 30" West, a distance of 1156.68 feet to the Southeast corner of that tract of land conveyed to Loren T. Montgomery et ux, by Deed recorded in Book 242, Page 404, of the Deed Records of Umatilla County, Oregon, which is the point of beginning of this description; thence continuing North 89° 55' 30" West, along the South line of said Montgomery tract, a distance of 87 feet; thence North 0° 04' 30" East, 10.0 feet; thence South 89° 55' 30" East, a distance of 87 feet to the East line of said Montgomery tract; thence South 0° 04' 30" West along the East line of said Montgomery tract, 10 feet to the point of beginning.

All being in Township 2 North, Range 32, East of the Willamette Meridian, in the County of Umatilla and State of Oregon.

Excepting any and all water rights of way.
