TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY:

We, the undersigned Board of County Road Viewers, heretofore instructed to view said road, submit the following report;

Pursuant to your order, we met at Pendleton, Oregon on the 6th day of November, 1923 and having qualified as viewers proceeded to view said road.

We find that the road as laid out and described in your Resolution, from the place of beginning, Station 0 / 00, to Station 534 / 50 is a necessary and practicable one and a benefit to the public. From Station 534 / 50 to the northerly terminus of the said road, we find that the routing as described in said Resolution should be changed to follow the revised location of the Oregon - Washington Highway as adopted by the Oregon State Highway Commission. Said revised location being described as follows;

Beginning at Station 534 / 50 P.O.T. of the survey as described in your Resolution,

Said Station 13 / 70.0 being a point on the Section Line approximately 1080 feet North of the Section Corner common to Sections 27, 28, 33 and 34, Township 2 North, Range 32 East, W.M. and the point of ending as described in said Resolution.

We find the above described location to be a necessary and practicable one and a benefit to the public.

(2) Report of County Road Viewers, Road No. 832.

Therefore we respectfully recommend that the road as described in said Resolution from Station 0 / 00 to Station 534 / 50 and continuing thence, as described above, on the revised location be opened and established as a County Road of Umatilla County, Oregon.

We find that the lands through which the said road is laid out are damaged in the sum of nothing.
