be presented to the How County Court of the State
of Oregon for Umatilla County at the next
regular term of said Court to wit at the
September term 1883; praying for the view
survey location and establishment of a
County road commencing at a stake driven
on the County road running from ranch of O. A. Thomson
on Butter Creek to Echo between the 5th and 6th
mile posts on said road; ^{one quarter (1/4) mile East of said 5th mile Post} thence running
northeastly to the south end of the Lane Survey the
Tul Lane at the quarter section post between
sections 7 and 18 in T¹ P³ R²⁹ East, thence north
along said Lane to the quarter section post
between sections 6 and 7 in said T¹ P³
Range, thence north on same line in middle
of section 6 to the T¹ P³ line thence east
