ORDER NO. RD95-009

As the Umatilla County Board of Commissioners deem it is in the best interest of the County to transfer the portion of County Road No. 1386 (Circle Road) from the intersection of County Roads 1388 and 1386 to the East 1/4 Corner of Section 8, T. 1 South, R. 32 E.W.M. to the City of Pilot Rock in Umatilla County, Oregon, and

IT APPEARING that on January 18, 1991 the Umatilla County Board of Commissioners unanimously voted to transfer ownership of said road to the City of Pilot Rock, and

IT APPEARING that on January 22, the City of Pilot Rock and Umatilla County executed an agreement to annex said road into the Pilot Rock City Limits, and

IT APPEARING that no ownership transfer agreement was ever executed, and

IT FURTHER APPEARING that a Public Hearing was held the 19th day of April, 1995, at 10:30 a.m. in Room 114 in the Hearing Room of the Board of Commissioners in the Umatilla County Courthouse, Pendleton, Oregon; that notice of the hearing and of the time and place of the hearing was given as provided by law; and considering any and all testimony, the Board of Commissioners finds it would be in the public interest to transfer jurisdiction of Circle Road No. 1386 from the intersection of Circle Road and Stock Drive Road No. 1388 to the east 1/4 corner of Section 8, Township 1 South, Range 32 E.W.M. to the City of Pilot Rock, Oregon.

NOW THEREFORE, IT IS ORDERED that the County of Umatilla hereby offers to the City of Pilot Rock jurisdiction over the above described portion of County Road No. 1386 (Circle Road). The City of Pilot Rock is hereby requested to accept the County's offer at the City's earliest municipal legislative hearing.
