COOPERATIVE MAINTENANCE AGREEMENT

This agreement made this 27th day of December, 1954, by and between the Umatilla County Court and the Morrow County Court, both of the State of Oregon, hereinafter called First Party and the Second Party respectively.

WITNESSETH:

Whereas, the First Party and Second Party desire to cooperate in an exchange of maintenance work of certain road sections for the mutual benefit of both agencies:

Now Therefore, in consideration of the several promises to be faithfully performed by each, as hereinafter set forth, the Parties do mutually agree as follows:

Description of Project

Article 1. This Agreement covers maintenance of the Umatilla County Road along Butter Creek across Sections 19, 30, 29, 32, and 33, T1N, R29E.W.M., hereinafter called Road Project 1 and the Morrow County Road along Butter Creek across Sections 3, 2, 1, and 12, T1S, R29E, hereinafter called Road Project 2.

Maintenance

Article 2. The First Party shall maintain Road Project 2 and the Second Party shall maintain Road Project 1. Maintenance shall consist of normal blading, weed burning and culvert and bridge cleaning when needed.

It is agreed that repair or replacement or installation of bridges, culverts, signs, fences, and cattleguards, or reconstruction or graveling of these various Road Projects shall be done by the Party in whose County the road physically exists and is not to be considered a part of this agreement.

Period of Agreement

Article 3. This agreement shall remain in full force and effect until terminated by written notice of either Party. However, said termination notice shall be given not less than 90 days before the effective termination date.

Share of Costs

Article 4. It is agreed that each Party shall pay the full costs of the maintenance on the projects herein assigned to them.
