Now on this day comes the Petition of John A. Gross and 14 others praying the Court to appoint viewers and surveyor to view out^{Survey} located a proposed Road for a County Road in and for Umatilla County, Oregon, The description of said Road is as follows to wit: Commencing at the Northwest corner of Section 32, running thence East a little over two miles along the north line of Sections 32-33+34 to the intersection of the road running from Kellie through Greasewood Flat to Vansycle Canyon. All the above numbered land is in Township 5 North Range 33 E. U. M.

And it appearing to the Court from the proofs^{and} papers filed herein that due notice of the pendency of the proceeding had been given by the posting of notices as by required by law and that twelve of said petitioners were resident householders living in the vicinity of the proposed road location for a County Road, and that a good and sufficient bond had been given as by law required.
