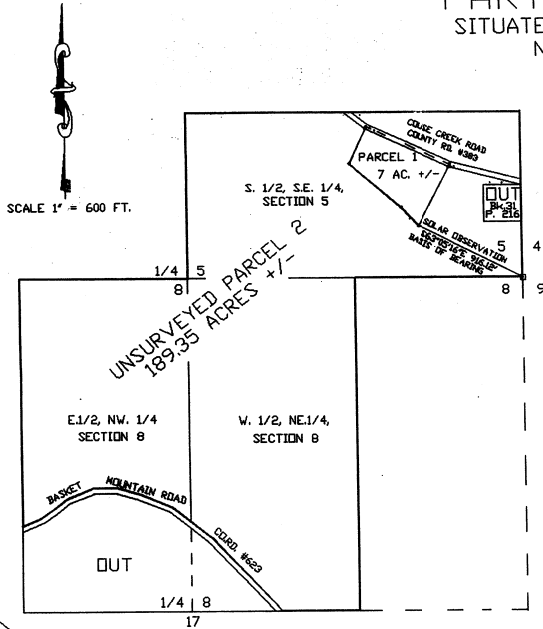

NARRATIVE

The purpose of this survey at the request of Fred I. Reichow, located in the SE 1/4 of Sec. 5 and the N 1/2 Sec. 8 T.4N., R.36E.W.M. is partition the deed recorded on R12, Pg.879, into two parcels. I did this by surveying out the smaller parcel and mapping the remainder. The basis of bearing for this survey is from a solar observation.

There is no U.S.G.S. triangulation station within 0.5 mi of this partition.
 A Topcon GTS 2-B, Geodetic Total Station was used on this survey.
