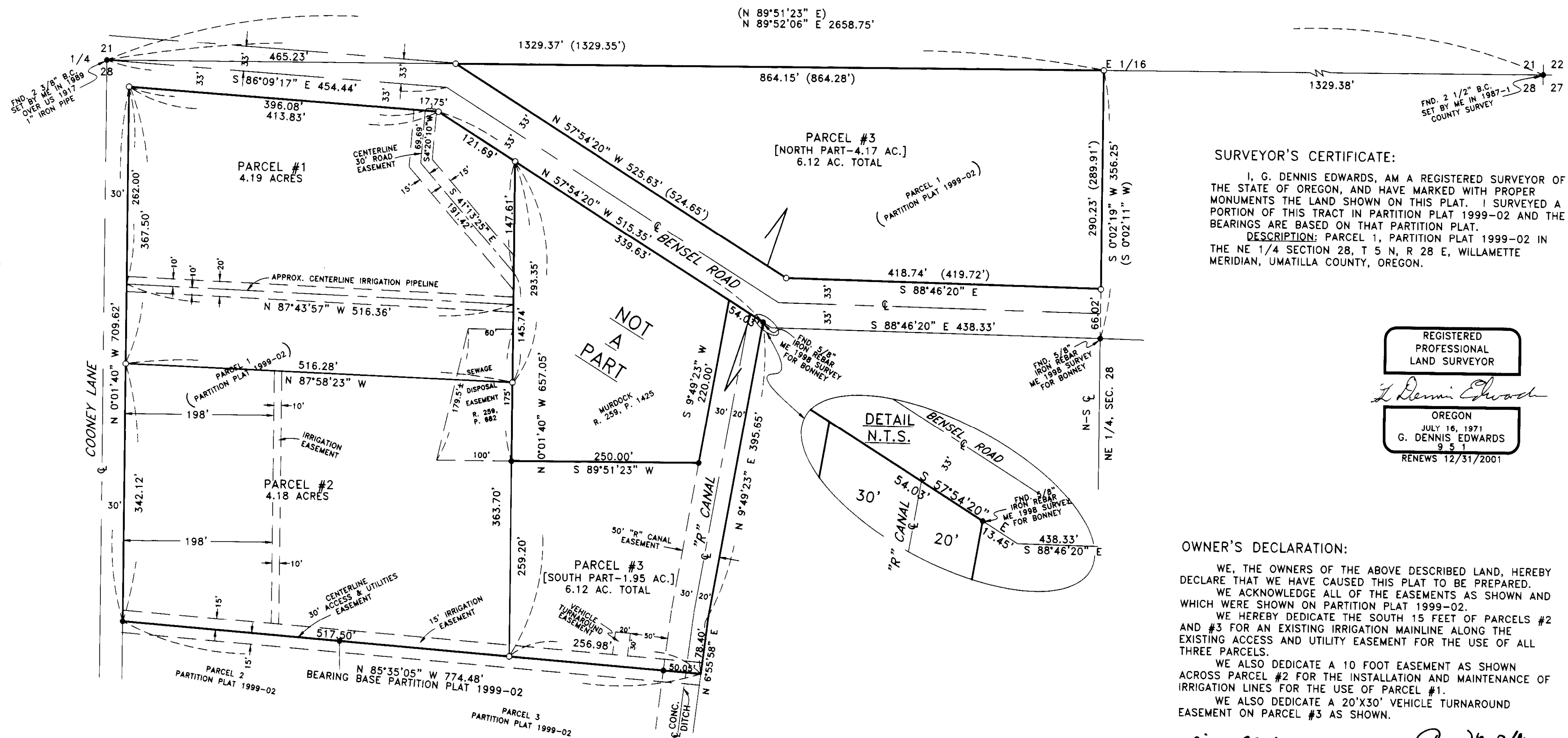

WE, THE OWNERS OF THE ABOVE DESCRIBED LAND, HEREBY DECLARE THAT WE HAVE CAUSED THIS PLAT TO BE PREPARED. WE ACKNOWLEDGE ALL OF THE EASEMENTS AS SHOWN AND WHICH WERE SHOWN ON PARTITION PLAT 1999-02. WE HEREBY DEDICATE THE SOUTH 15 FEET OF PARCELS #2 AND #3 FOR AN EXISTING IRRIGATION MAINLINE ALONG THE EXISTING ACCESS AND UTILITY EASEMENT FOR THE USE OF ALL THREE PARCELS. 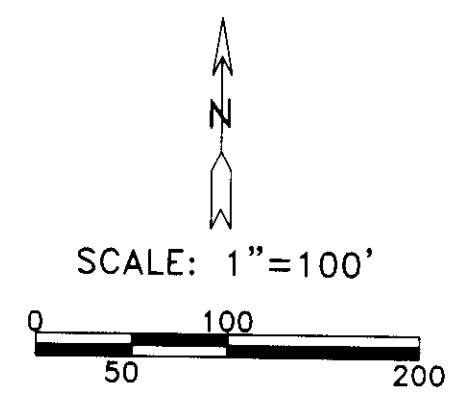
