SURVEYOR'S CERTIFICATE & NARRATIVE:

I, G. DENNIS EDWARDS, AM A REGISTERED SURVEYOR OF THE STATE OF OREGON AND HAVE MARKED WITH PROPER MONUMENTS THE LAND SHOWN ON THIS PLAT.

THE PURPOSE OF THIS SURVEY IS TO PARTITION THAT TRACT OF LAND DEEDED TO ROBERT AND GEORGETTE SHANNON ON REEL 236, PAGE 1643, UMATILLA COUNTY DEED RECORDS, INTO TWO EQUAL PARCELS FOR THE PENDING SALE OF THE NORTH PARCEL.

I SURVEYED THE NORTH LINE OF THIS TRACT IN A 1988 SURVEY FOR THE JOHNSTON ESTATE. IN THAT SURVEY I USED A 1 1/2" IRON PIPE AT THE NE CORNER OF SECTION 20 FOR THE SECTION CORNER. IN COUNTY MONUMENTATION SURVEY 1991-2 I DETERMINED THAT SAID IRON PIPE WAS SOUTH OF THE ORIGINAL CORNER AND I SET A NEW MONUMENT 17 FEET NORTH IN THE CENTER LINE OF AN EAST-WEST COUNTY ROAD WHICH WAS SURVEYED AS #609 IN 1907. AS IT TURNS OUT THERE HAVE BEEN MANY SURVEYS DONE IN SECTIONS 16, 20, AND 21 USING THAT IRON PIPE.

FOR THIS SURVEY I AM ALSO USING SAID IRON PIPE BECAUSE IF MY 1991 MONUMENT WERE USED I WOULD MISS THE FENCE CORNERS SHOWN ON THIS MAP A GREATER DISTANCE THAN WHAT I DO USING THE IRON PIPE.

DESCRIPTION: THE SOUTH 613.00 FEET OF THE EAST HALF OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SECTION 20, T 4 N, R 28 E, WILLAMETTE MERIDIAN, UMATILLA COUNTY, OREGON, EXCEPTING THEREFROM THE EAST 33 FEET LYING IN COUNTY ROAD #1187. SAID TRACT IS DESCRIBED IN A DEED TO MICHAEL J. AND HELGA A. SHANNON RECORDED ON REEL 448, PAGE 443, UMATILLA COUNTY DEED RECORDS.

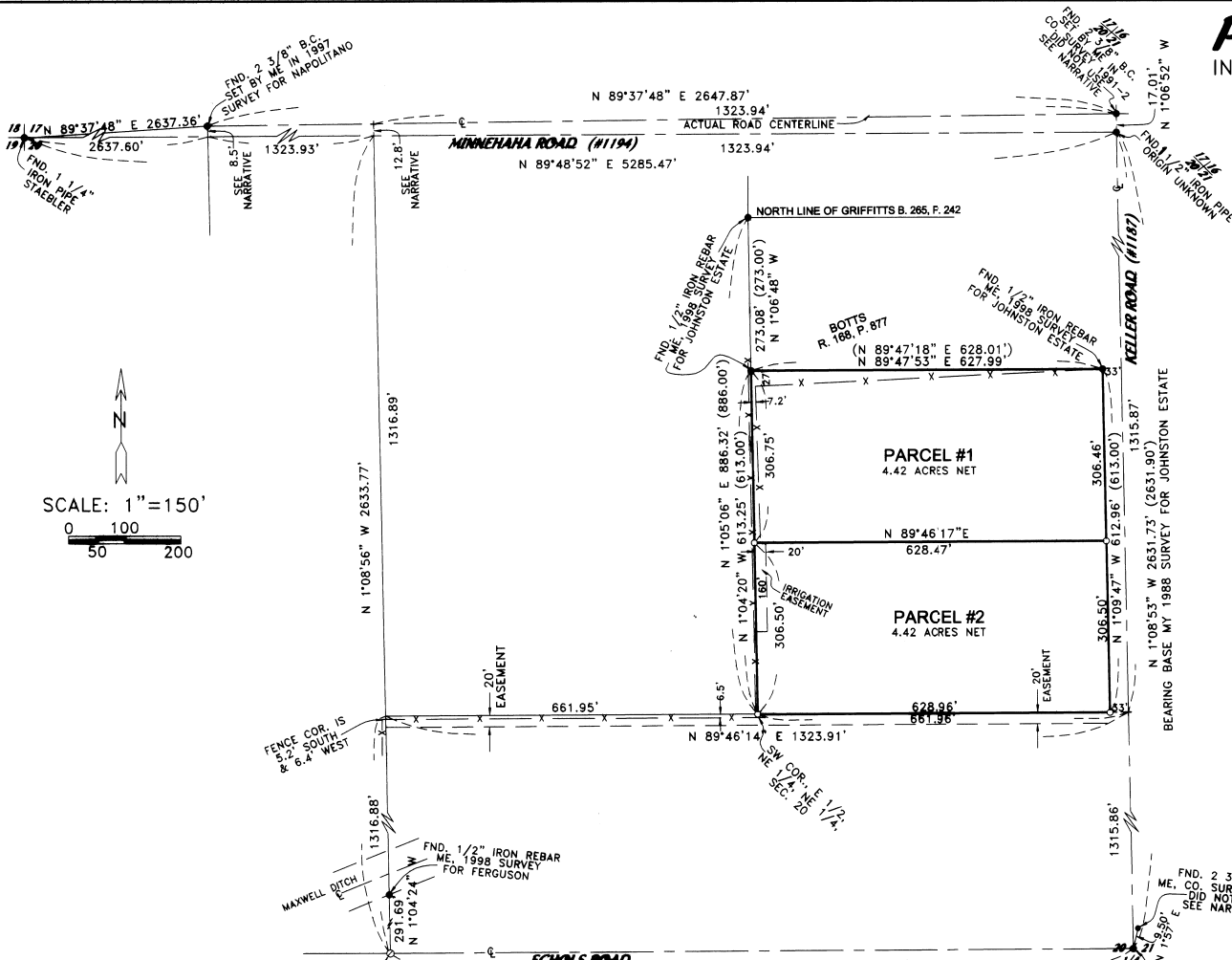
