THIS SURVEY WAS PERFORMED AT THE REQUEST OF STEVE RICHARDS, REPRESENTATIVE FOR TAMERA BROGOITTI, TO PERFORM A PARTITION PLAT SURVEY TO SPLIT OFF AN APPROXIMATE 6.15 ACRES FROM THE CURRENT TAX LOT 100 OF ASSESSOR'S MAP 2N3207. LOCATED BETWEEN GRAYBEAL SUBDIVISION, BOOK 14, PAGE II, AND PARTITION PLAT 1996-05, BLA SURVEY 99-165-B, AND PARCEL I OF PARTITION PLAT 1999-47 FOR THE CITY OF PENDLETON.

I HOLD THE BEARING BASE USED ON THE ABOVE MENTIONED SURVEYS, ALL DONE BY WELLS, AND HOLDING THE SAME BEARINGS. THE ROTATION FROM NAD83 ORNSPC GRID NORTH TO THIS BEARING BASE IS 1°19'42" CLOCKWISE, AND SCALE FACTOR OF 0.99984706'/, GROUND TO GRID.
