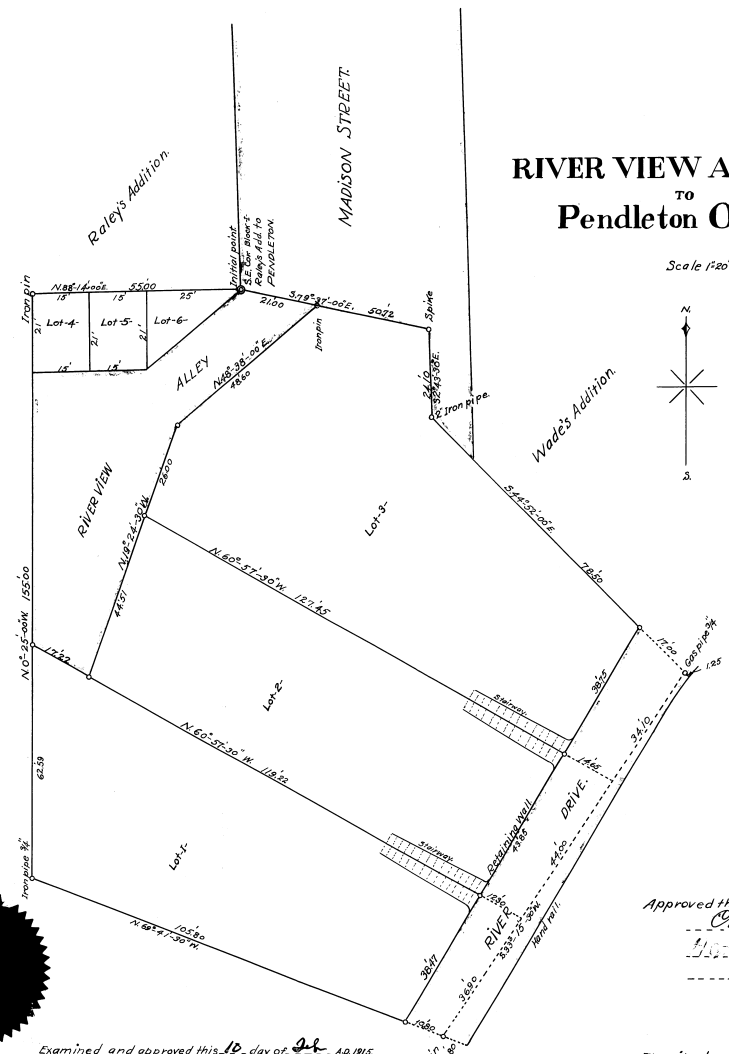
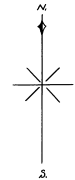
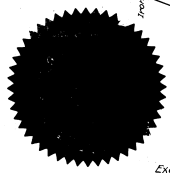


# RIVER VIEW ADDITION TO Pendleton Oregon
