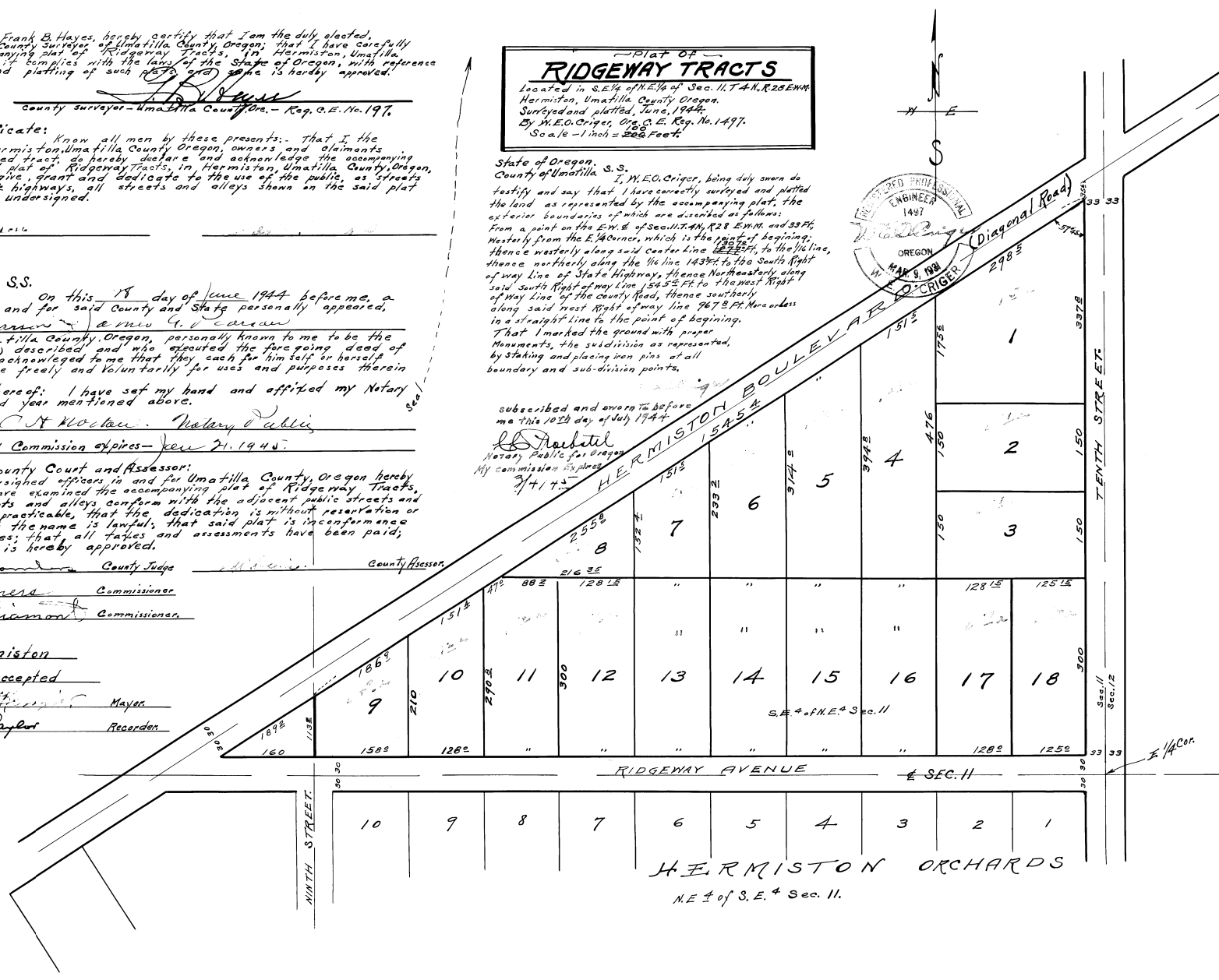
**Certificate of County Court and Assessor:**
