BEGINNING AT THE S.E. CORNER OF THE N.E. 1/4 OF THE S.W. 1/4 OF SECTION 17 TWP 5 N., R.28 E.W.M. WHICH POINT IS S. 0°-04'-03" E.-1325.19 FEET FROM THE CENTER OF SAID SECTION 17 AND ALSO 3985.30 FEET SOUTH OF THE NORTH 1/4 CORNER OF SAID SECTION 17 AND AT POINT I REMOVED AN OLD WOODEN STAKE AND PLACED A STONE 10" X 10" X 24" THE TOP OF WHICH IS 6" UNDER THE SURFACE OF THE GROUND AS PER OREGON CODE SEC. 95-1304 ANNOTATED: THENCE N. 0°-04'-03" W. ALONG THE NORTH-SOUTH CENTERLINE OF SAID SECTION 17- 1056.78 FEET TO THE CENTER OF THE UMATILLA RIVER; THENCE ALONG THE CENTER OF THE UMATILLA RIVER S. 78°-02' W.- 461.37 FEET: THENCE S. 77°-05' W.- 468.18 FEET: THENCE S. 84°-58' W.- 245.91 FEET: THENCE S. 70°-27' W.- 175.60 FEET TO THE NORTH-SOUTH CENTERLINE OF THE S.W. 1/4 OF SAID SECTION 17; THENCE ALONG SAID NORTH-SOUTH CENTERLINE S. 0°-49'-33" E.- 795.6 FEET TO THE CENTER OF THE S.W. 1/4 OF SAID SECTION 17; THENCE ALONG THE EAST-WEST CENTERLINE OF SAID S.W. 1/4 SECTION 17 N. 89°-08'-57" E.- 1308.04 FEET TO THE POINT OF BEGINNING.

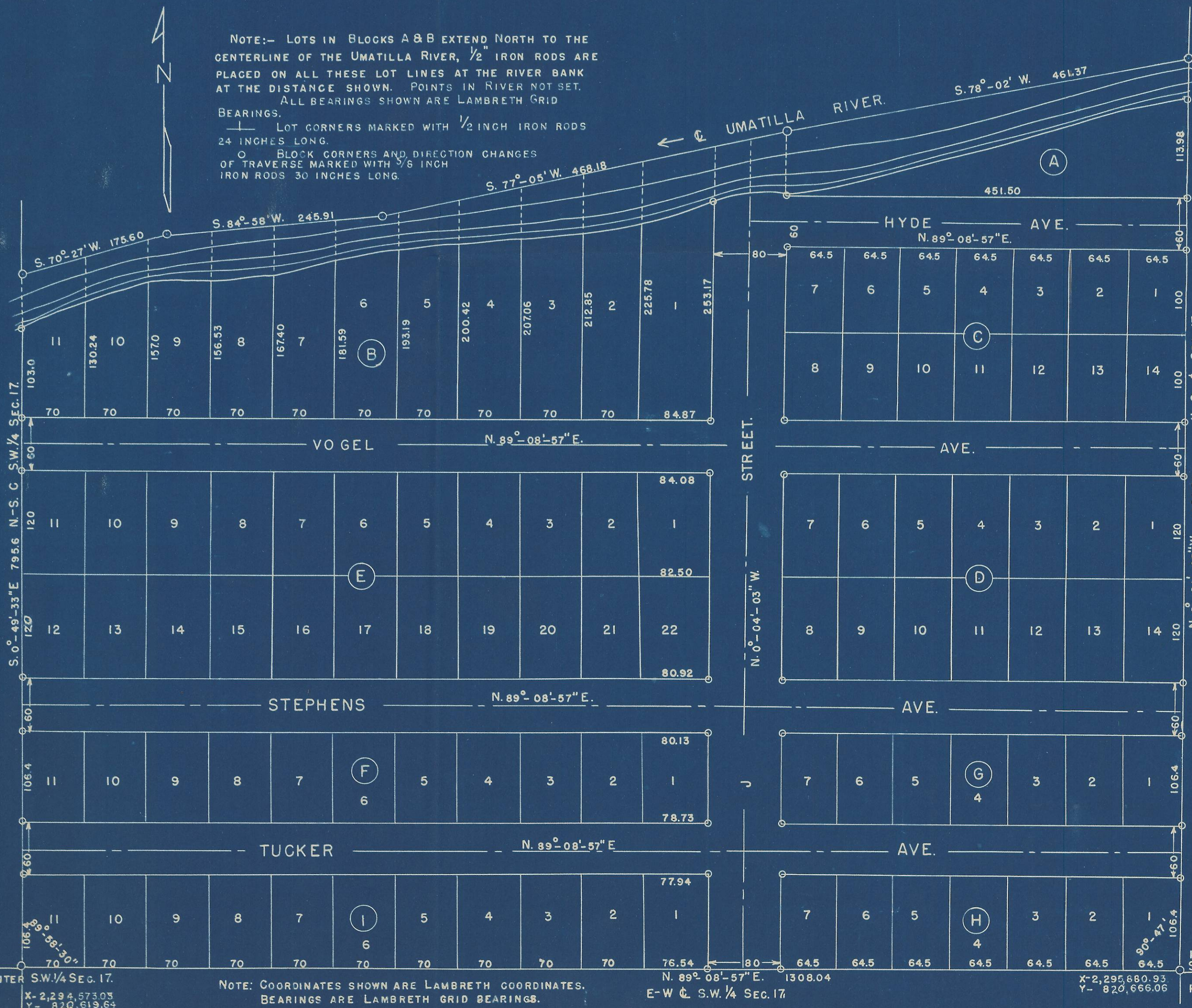
