

SURVEYOR'S CERTIFICATE

I, Stephen K. Haddock, a Registered Professional Surveyor in the State of Oregon, do hereby certify that I have correctly surveyed and marked with legal monuments the lands described herein. I do also state that the initial point is monumented with a 5/8" x 30" Iron Rebar having an orange plastic cap stamped WTS and 56295LS. This monument falls S66°24'10"W, 550.07 from Reservation Addition boundary monument stone RB12.

LEGAL DESCRIPTION

A portion of that land conveyed to Homestead Youth Lodge, Inc., by the Statutory Bargain and Sale Deed recorded on December 16, 1997 in Microfilm Reel 321, Page 33, deed records of Umatilla County, Oregon, said portion being located in the Southeast Quarter of the Northeast Quarter of Section 11, Township 2 North, Range 32 East, W.M., Reservation Addition (Originally platted as Reserve Addition) to the Town (now City) of Pendleton, in said Umatilla County, said portion being more particularly described as Lots 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, and 14 of Block 249, Lots, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, and 14, of Block 250, and all that part of Southeast Sixteenth Street (formerly Hill Street in said Reservation Addition) vacated by City of Pendleton Ordinance No. 4037 bearing the effective date of August 4th, 2025 lying southerly of a line running Southwesterly from the Southwest corner of Lot 2, Block 249 to the Southeast corner of Lot 2, Persinger Replat, as recorded in Plat Book 18, Page 15, plat records of said Umatilla County and shown on this replat.

Subject to: Rights of Reversion, including the terms and conditions thereof: In favor of the City of Pendleton as contained in that Bargain and Sale deed recorded on May 31st 1977 in Microfilm Reel 19, Page 192 in the Office of County Records. Umatilla County, Oregon.

NARRATIVE OF SURVEY

This survey was performed at the request of Ms. Elisa Doebler-Irvine, Ph. D., Executive Director of Homestead Youth & Family Services, Inc.. The purpose of the replat is to eliminate the interior lot lines of those parts of Blocks 249, 250, and that part of vacated Southeast #16th Street as described in the Surveyor's Certificate thereby creating one single parcel so that a proposed accessory structure will be on the same parcel with the primary structure.

The control for this survey was the found Reservation Addition monuments at the intersections of SE Isaac Avenue with 9th and 17th streets along with boundary stones RB10 and RB12 as also held in the Pershinger Replat recorded in Umatilla County Plat Book 18, Page 15.

The survey was performed with a Trimble R8S base - rover pair in RTK mode.
