BASIS OF BEARINGS: ALL BEARINGS ARE REFERENCED TO THE NORTH SIDE OF THE EQUATOR ON THE OREGON STATE PLANE COORDINATE SYSTEM, NORTH ZONE.

MARGINALIA: THIS SURVEY WAS PERFORMED AT THE REQUEST OF BOB BUCHANAN TO PROPERTY DESCRIBE AND MONUMENT UNITS ACQUIRED FROM RANDY PERKINS AND AGGREGATED WITH OTHER LANDS OWNED BY HIGH RIDGE PROPERTIES. THIS SURVEY WAS PERFORMED AS A COMBINATION STATIC AND REAL TIME KINEMATIC SURVEY USING TOPCON DUAL MONUMENTS SHOWING ORIGINALLY VISITED PER OUR 2008 SURVEY (08-208-C) AND 2008 SURVEY (PERKINS BLA SURVEY 08-161-B), WERE REVISITED DURING THE COURSE OF THIS SURVEY.

THE SECOND BOUNDARY ADJUSTMENT WITH PERKINS IS DUE TO PROJECT PLAN CHANGES TO THE PERKINS SURVEY FILED AT 08-035-C, DOES NOT SHOW THE KING ADJUSTMENTS. ALTHOUGH IT ACCURATELY DEPICTS THE BOUNDARY OF THE PARCEL TO BE ACQUIRED FROM PERKINS BY HIGH RIDGE.

PERKINS HARDER BOUNDARY NOTES: 1. CURRENT DEEDS STATE THENCE TURNING TO THE WEST OF CENTERLINE, AND 49.5 EAST OF CENTERLINE FEET MORE OR LESS TO THE NE CORNER OF THE SE 1/4 OF THE NW 1/4. THIS CALL IS VERY AMBIGUOUS AND WHEN PAID TO THE NE CORNER OF THE SE 1/4 OF THE NW 1/4, THIS CALL IS VERY AMBIGUOUS. 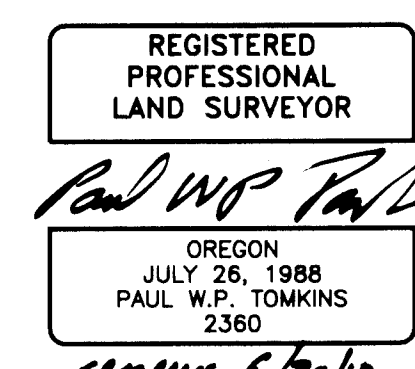

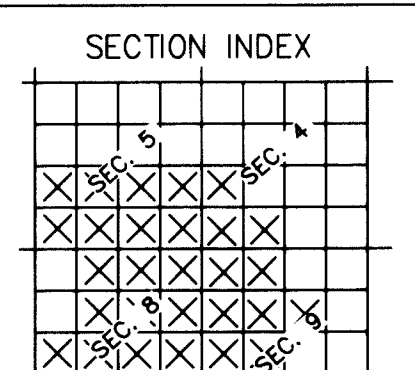
