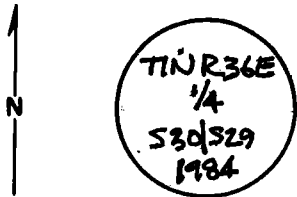

Painted a 6 inch red band around all BTs and attached bearing tree and land survey monument signs.

Set a steel fence post approximately 5 feet North with 54-9 sign attached.
