DESCRIBE BEARING TREES OR OTHER OFFICIAL ACCESSORIES FOUND

A 38" douglas fir bears N83°E (N85°E with declination 20°E)-21.1 feet, with healed blaze.  
A 26" ponderosa pine bears S17 1/2°E-46.5 feet, pitched over, with scribing.

Set a steel fence post 5 feet East of monument with 54-2 and 54-9 signs attached.

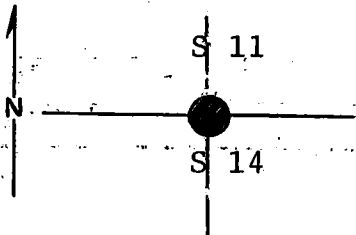

MONUMENT. DESCRIBE NEW MONUMENT SET, OR WORK DONE TO PRESERVE EXISTING MONUMENT

Set a 30x2½" iron pipe with 3" brass cap marked as shown, 26" in ground, for the 1/4 section corner between sec. 11 & 14, from which a new BT:

A pine 24" diam. bears S16°E. 45.1 ft. dist. marked T1S R36E 1/4 S14 BT. Distance taken to a brass washer in the blaze of the tree. Set a steel fence post approx. 5 ft. East from corner with Forest Boundary sign attached. Used steel tape and magnetic compass with declination = 20° East.
