MONUMENT AND ACCESSORIES FOUND:

Found and held railroad tie fence corner with ancient fences South and East as best remaining evidence of original corner location. We excavated around the post but found no trace of marked stone called in Road Survey No. 570. The area has flooded many times in the past and if Road 570 was constructed, it could have destroyed the corner stone. There is no evidence of a road at this time. The fence line running East, then turning North closely matches deed call dimensions for the ownership line in this area.
